Eight gainers push Prime Index up 28.39 points to close at 7,829.09 points. YTD return up to 60.15%.

The GSE Composite Index rose to 7,829.09 points with its year-to-date return at 60.15%. The GSE Financial Stock Index also climbed to 3,694.87 points with a 55.20% YTD return.

Total market capitalization closed higher at GH¢1.58 billion. 4,986,838 shares were traded representing an 85.04% day-on-day drop. These trades had a total value of GH¢9,308,237.82. EGH led the gainers today to close at GH¢10.00.

TOTAL was the most traded counter on the day trading 200,500 shares with a total value of GH¢7,033,545.00. Following it were GGBL, MTNGH, FML and CAL in that order.

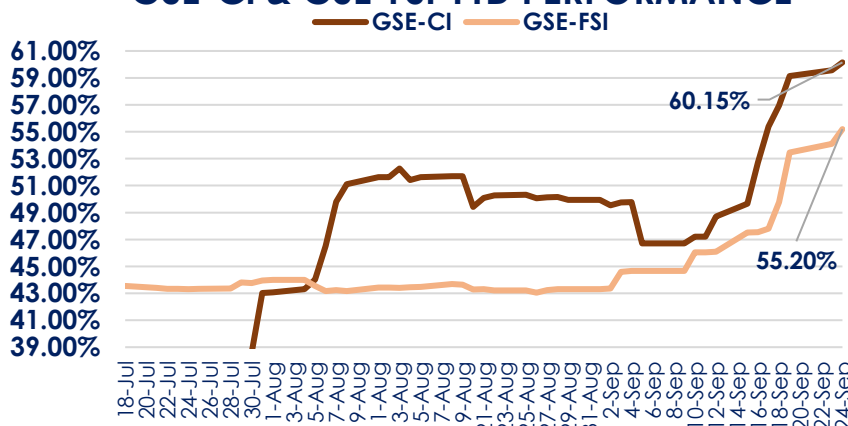
SUMMARY: AUGUST 2025 MARKET ACTIVITIES

The GSE Composite Index was up by 338.08 points m/m in August 2025 (returning 49.95% YTD, compared to 39.28% for the same period last year). The GSE financial stock index dropped by 15.10 points to place its YTD gain at 43.31%. Volumes traded slumped 87.19% spike, while total turnover also fell by 88.23% m/m. The price gainers for the month were ETI (6.49%), CAL (5.88%), UNIL (0.44%) and ACCESS (0.12%). Conversely, SCB, BOPP and EGL recorded the steepest dips, shedding off 0.04%, 0.26% and 1.72% of their market prices respectively.
