FIXED INCOME MARKET UPDATE **GFM**

HIGHLIGHTS: At the latest Treasury auction (Tender #1980), total bids worth GH¢4.51 billion were received, of which 99.71% were accepted. The 91-day bill continued to dominate demand, accounting for GH¢3.61 billion of accepted bids, followed by the 182-day and 364-day papers at GH¢612.63 million and GH¢279.34 million, respectively.


Yields continued their upward trajectory across all maturities. The 91-day bill climbed 103 basis points to 10.93%, the 182-day advanced 92 basis points to 12.61%, while the 364-day edged up 51 basis points to 13.02%, reflecting sustained investor demand for shorter-term instruments amid tightening liquidity conditions.

Looking ahead, the upcoming auction (Tender #1981) aims to raise GH¢5.68 billion, marking a 16.91% drop in the target size compared to the previous tender. The issuance will cover the usual short-term tenors — 91-day, 182-day, and 364-day bills — and is scheduled for settlement on 17th November 2025.


91-Day bill , 182-Day bill & 364-Day bill


