**Guidelines for E-Levy implementation to be released April 25 – GRA:** The Ghana Revenue Authority is expected to release guidelines on how the Electronic Transfer Levy (E-levy) will be rolled out. The guidelines, which is to be released on Monday, April 25 will provide further details on how the levy will be applied by financial institutions, mobile money operators, fintech among others. These guidelines will seek to address certain concerns of the public in the wake of the imminent implementation of the tax policy which takes effect from May 1, 2022. According to GRA, the delay in releasing of the guidelines was to allow for stakeholder engagements over the levy. (Ghanaweb)

Forbes took cognizance of MIIF’s strategic acquisition of over fourteen million shares and circa 4.65% stake in Asante Gold Corporation, a Canadian and Frankfurt listed gold producing company which operates in Ghana. Forbes Monaco and Aurum Monaco both highlighted MIIF’s proposed US\$500million Small-Scale Incubation Programme as transformational for Ghana’s gold mining sector (thebftonline)






